## Airport Shuttles

Discover Ames is offering round trip shuttle service for Odyssey of the Mind teams from the Des Moines International Airport (DSM) ONLY. DSM is a 45-minute drive from Ames. The arrival shuttle will run between the airport and OM Registration site at Sukup End Zone Club at Jack Trice Stadium.

Shuttles will be scheduled to accommodate Odyssey group arrivals and are not available at regular intervals or to other destinations. Delayed flights will be accommodated as quickly as possible.

Arrival service is available Monday, May 20 and Tuesday, May 21. Limited arrival shuttles on Sunday, May 19 and Wednesday, May 22.

Departure service is available Friday, May 24 and Saturday, May 25. No departure shuttles are available on Sunday, May 26.

#### What you will need to request an airport shuttle:

- Cost per person for a round trip shuttle (arrival and departure) is \$75; paid with a credit card or by check (payment must be received by time of service).
- Deadline to request an airport shuttle is: May 3, 2024
- Team Membership Number
- How many people are you requesting a shuttle for
- If your team is traveling on several different flights; you will need to complete the reservations multiple times based on travel schedule.
- Arrival Airline, Arrival Flight Number, Arrival Date, Arrival Time (arrival time of the flight NOT the time you want a shuttle)
- Departure Airline, Departure Flight, Departure Date, Departure Time (time of the flight NOT the time you want a shuttle)
- On-site Contact Name, email, cell phone of the adult(s) that will be on-site with the group on travel days. The individuals listed in this section will be receiving the communication from Discover Ames on their shuttles.

# **Team Registration**

#### Location

Registration will take place at Iowa State University's **Sukup End Zone Club** (SEZ Club).

Please note this is a different venue from the 2018 & 2022 Odyssey of the Mind World Finals.

# Where can I find Sukup End Zone Club (SEZ Club)?

SEZ Club is located on the south side of Jack Trice Stadium and is near the intersection of University Blvd and SE 16th Street, Ames, IA. Sukup End Zone Club shares a parking lot with Reiman Gardens.

From Interstate 35 to US-30 West. Travel on US-30 West to South University Blvd in Ames. Take exit 146 from US-30 West to University Blvd. Continue North on University Blvd about 1-mile to the intersection of SE 16th Street and University Blvd. Turn left onto SE 16th Street and make another immediate left (it will appear you are entering Reiman Gardens parking lot).

# Where can I park at Sukup End Zone Club (SEZ Club)?

There is free parking in lots S2, S3, S5 & S6. Please note that one or two of these lots will be closed to serve as our shuttle bus transfer station. Please avoid parking in Lot S1; this is Reiman Gardens parking lot.

\*Wednesday registration will take place in the Room 2630 at the Memorial Union located on the campus of Iowa State University.

#### Coaches

Please proceed to the 2nd level of Sukup End Zone Club to finalize your team's registration process.

- Turn in team contract, medical and media release forms, and insurance waiver.
- Receive your team's housing assignment.
  - If assigned to a residence hall; you will receive your residence hall keys and further details.
  - If assigned to a team hotel; you will receive a map and directions and further details.
- · Receive other important OM materials.

#### **Teams**

The 1st level of SEZ Club is available for teams to wait for their coaches while they finalize the registration process. Teams may pin trade, socialize with other Odyssey of the Mind participants, take a selfie at the OM photo station, flip through a Discover Ames visitors' guide, or purchase your 2024 OM apparel and swag at the souvenir/merchandise stand.

# Housing

# Campus Housing

Most residence rooms are double occupancy rooms; however, there are a few single, triple and quad occupancy rooms. The majority of housing areas have group bathrooms (shared by a floor) located nearby the sleeping rooms. A few housing accommodations have suite-style sleeping rooms with several rooms (up to four people) sharing a bathroom and some space is like an apartment with kitchenette and living room. Beds are single (twin) beds, most of which will be lofted over room furniture, and a few futon-style beds. Lofted beds have ladder to help the guests access the bed in the lofted space. Air-conditioned rooms are not guaranteed. Refrigerators are not supplied in any residence rooms unless requested for medical use. Please plan accordingly when making your housing plans.

Your team will be pre-assigned rooms in residence housing on campus. In order to accommodate all teams, it will be necessary to assign one person to every available bed. This means that if a team has 9 persons assigned to rooms with a total of 10 beds, there may be a person from another team of the same gender and similar age assigned to the remaining space. Males and females may be assigned within the same residence hall room if requested. Males and females may be assigned within the same suite or apartment, but not within the same sleeping room unless requested. Please inform team members of this possibility.

Each person will be provided with a pillow, pillowcase, sheets, blanket, 2 towels, 1 washcloth & soap. Daily towel exchanges will be available at a centralized location. Laundry facilities will be available within the residence area; cost of laundry and detergent is the person's responsibility.

# Off Campus Housing

Some teams will be assigned to off campus housing. These locations will have shuttles to campus (shuttles will not be a continuous loop; a shuttle schedule will be provided at team check in and posted in the lobby of the hotels with morning shuttle times and evening return times from campus as well as late night shuttle schedule for the special events during the week). All teams housed off-campus by the university will be provided breakfast at their hotel and attendees will eat lunches and dinners at a designated dining center on campus.

# **Special Housing**

If you have a team member with a medically required special housing assignment need (e.g., "uses wheelchair/quadriplegic and must have wheelchair accessible room & bathroom" or "has broken leg and using crutches/cannot manage a lofted bed/needs minimal stairs"), list the member's full name, contact telephone number, email address and description of requirement when you submit your Lodging/Meals Reservation. Please indicate only medically required housing and dining needs that may affect placement.

#### 24-Hour Assistance

A 24-Hour Conference Desk will be located in each residence area. Guests who have questions about housing or dining should feel free to call or stop by their Conference Desk. The 24-Hour Desks can store medications requiring refrigeration (refrigerators are not supplied in all residence rooms). Bring medications in small, well-labeled containers.

# Lost Keys - Residence Halls

Be sure to keep track of your keys! At check in, you will receive an envelope with all your keys, use this as a handy resource to gather them all to turn in at check out. **Keys must be returned at check-out; charges will be assessed for unreturned keys (up to \$150).** If lost keys are found, turn them in to one of the 24- hour residence hall desks or to the OM information desk.

# **Dining**

# **Dining Centers**

Teams will be assigned to a specific dining center for your meals. All persons who have purchased Odyssey of the Mind housing package will be issued a color-coded wristband allowing them into the appropriate dining center. Meals typically include a selection of entrees, hot and cold side dishes, salad bar, fresh fruits and vegetables, and a variety of desserts and beverages. ISU Dining may choose to substitute some meals as pick-up-and-go meals when appropriate (notices to be shared at arrival).

# Off Campus Dining

In addition to the meals offered as part of your package, Ames offers a variety of dining options in the community. If your plans include dining off-campus, visit DiscoverAmes.com for options.

#### **Guest Meals**

Individual guest meals can be purchased at the entrance of the dining center or at the Memorial Union.

Convenience stores are located within the residence facilities and on the ISU campus. They carry a wide variety of beverages, snacks, ISU souvenirs, cards for residence hall washers and dryers, laundry supplies and personal care items.

Please note that on Iowa State campus, dining centers, Memorial Union, and Convenience Stores are cash-less; cards are only accepted for payment.



# Special dietary needs

Most of our dining centers are able to accommodate individuals with these allergens: dairy, egg, fish, shellfish, wheat, peanuts, tree nuts, and soy. When Registering, if anyone in your group has dietary allergies, please list the member's full name, contact telephone number, email address and list the allergens (see above list) for the medically-required dietary needs on the lodging & meals reservation. If you are requesting Halal or Kosher diets, please complete the form using the same process as above. Those who are unable to self-manage their dietary allergies, such as celiac disease, will be assigned to a specific dining area.

Many other dietary needs or preferences (such as for those who have diabetes; are vegetarians, etc.) can be accommodated simply by choosing appropriately from the wide variety of choices that will be available at each meal. These types of needs should not be listed on the lodging and meals reservation.

Please note, ingredients used in our recipes may be produced in a facility that may contain common food allergens such as, but not limited to: dairy, egg, fish, shellfish, wheat, peanuts, tree nuts, and soy. Food served in our facilities may not be allergen free even if they are initially made with products that don't contain the allergen.



# **Courtesy Reminders**

# Department of Residence and ISU Dining

- Smoking is prohibited on all university grounds, including parking lots and in all university-owned or operated buildings, residence halls and apartments.
- Alcoholic beverages are not allowed in any Department of Residence buildings and ISU Dining facilities.
- Water guns, ball playing, etc., are not allowed indoors.
- Firearms, weapons, ammunition, fireworks, explosives, and highly flammable materials are not allowed.
- Tampering with elevators, fire alarms, and other building property is prohibited. Complete evacuation of the building is required in the event of a fire alarm.
- For safety reasons, window screens may not be removed. A charge of \$50 will be assessed to occupant for removal.
- Guests must present their wristbands at all meals served within the ISU Dining facilities. Food and beverages may not be carried out of the dining rooms (for example, no filling of water bottles, coolers and mugs). Shirts and shoes are required in the dining center; swimwear and sleepwear are not acceptable attire.
- Guests shall not engage in conduct which is disruptive to other guests or University programs. Chaperones are responsible for the conduct of minors at all times.
- Quiet hours are from 11:00 p.m. to 8:00 a.m. Noise that can be heard outside of a closed door may be considered too loud for your neighbors at any time.
- Participants are not allowed in Department of Residence areas which are not assigned to their group unless accompanied by a responsible host registered for that area.
- · Always lock your door and take your keys even if you leave for "just a minute".
- Never leave suitcases/belongings unattended and make sure your belongings are clearly marked.

# **Clear Bag Policy**

The Iowa State Athletics Department has a clear bag policy for all ticketed events.

The following bag types are allowed:

- Plastic, vinyl, or PVC clear totes that do not exceed 12x6x12 inches and do not have a logo larger than 4.5x3.5 inches;
- One-gallon clear plastic freezer bags (i.e. Ziploc or similar);
- Small clutch bags no larger than 6x9 inches;
- Exceptions will be made for bags containing items required for medical, family, or child care.

#### Permitted Items:

- · Items required for medical, family, or childcare needs
- One 20oz. unopened or empty bottle of water per person

#### Prohibited Items include, but are not limited to:

- Alcoholic beverages
- · Artificial noisemakers
- Backpacks, fanny packs, purses (or any bag that is not clear)
- Cameras (a lens less than 6 inches is permitted in the Coliseum)
- · Chairbacks or stadium seats
- Coolers or containers
- · Beach balls
- Food and beverages
- Pets (with the exception of service animals used by disabled guests)
- Strollers
- Umbrella
- Video cameras
- Weapons
- · Tools, razor blades, scissors, etc.
- · Sealed packages of any kind, including gifts
- · Laser pointing devices, flashlights, or glowsticks
- · Selfie sticks, telescopic devices, tripods, or camera poles
- Hazardous items including, but not limited to, fuels, torches, lighter fluid, chemicals, paint, batteries, or aerosols

# **Parking**

# Residence Area Parking

Teams living in residence housing on campus will be able to park in assigned areas within easy walking distance of their living area.

# **General Parking**

Those not staying in residence housing on campus should park at the lowa State Center. There is no charge for parking in this area. The shuttle transfer station is located on the West side of C.Y. Stephens Auditorium near Lot F. The free shuttle is provided to central campus. Additional parking adjacent to central campus is available at the Memorial Union parking ramp with an hourly charge. Normal restrictions apply to fire lanes, spaces marked "handicapped parking," and spaces reserved for service vehicles. Other university lots are assigned to university staff. Please take care to avoid restricted areas.

#### Charter coaches

If your team is chartering a coach to bring you to Ames, please make the following arrangements with your driver. When on campus, the charter should park in the general lots at the Iowa State Center. At registration, pick up information on permitted pick up/drop off locations on campus. Parking is not allowed for buses on central campus, and waiting times are limited. Be sure to exchange cell phone numbers with your driver in case either your driver or the team need to make arrangements for an alternate meeting place.

# CyRide

CyRide, the city's public transit system, will operate a free bus service throughout the competition connecting the residence areas, central campus, and the lowa State Center. CyRide also will offer free rides throughout Ames for Odyssey of the Mind participants and coaches wearing their wristbands. CyRide will be operating during the following hours:

#### PREPARING YOUR SHIPMENT

Props may arrive between May 1 – Friday, May 17, 2024.

Pack props in cartons. All cartons must measure no more than 32" wide X 72" tall and must be less than 8' long.

Larger cartons must be constructed to allow for forklift use (see illustrations below). Any oversized crates received will be held at ISU Central Receiving and the team will be responsible for delivery to the competition site.



#### **GOOD CRATING:**

Offers durability and maximum protection.

Must be easy to move with a forklift or pallet jack.

Preferably uses a 4-way pallet as a base.

Uses Screws to secure - not nails.



### Props - continued

- Fill out (type or print legibly) the enclosed shipping label completely and attach the label securely to EACH carton
- Each carton shipped must be clearly marked and labeled with the official shipping label provided in this packet whether they are shipped by you or a third party.
- When shipping multiple cartons, mark each piece (i.e. Box 1 of 3, Box 2 of 3, Box 3 of 3)
- Cartons require member's name and number, address, mobile phone, e-mail,
   Problem name and division, and it must be shipped to the address provided on the shipping label.
- DO NOT PUT PROPS FOR MORE THAN ONE PROBLEM IN THE SAME CARTON/CRATE
- Props will be accepted beginning May 1, 2024
- Bring tools to open and reassemble your props. Iowa State University is unable to supply tools.

## Shipping Your Props

ALL shipments must be prepaid. ISU Central Receiving will not accept any shipments arriving freight collect or COD. Be sure to obtain a tracking number from your carrier for each carton/crate shipped.

# Full Truckload Prop Shipping

Full truckload shipments shall be loaded by Problem. Please have the carrier provide a manifest to ISU Central Receiving upon arrival.

# International Prop Shipping

ALL shipments must be prepaid. ISU Central Receiving, Odyssey of the Mind, and lowa State University are NOT the importer of record. ISU Central Receiving, Odyssey of the Mind and Iowa State University are not responsible for customs clearance, brokerage, taxes, duties or any other fees. The shipper must provide their own broker for customs clearance. ISU Central Receiving will not accept any shipments arriving freight collect, COD or requiring payment of fees.

# **Shipment Tracking**

Check your carrier's website to see if your shipment has been delivered to Iowa State University Central Receiving. You may check the Iowa State University tracking website to see the status of where your prop is located at ISU: https://isu.sclintra.com/OTM

Props will be grouped according to problem and division and delivered to the designated prop storage area near each competition site by Tuesday, May 21.

## While you are here

A Prop Information booth will be available Monday and Tuesday during registration at Sukup End Zone Club. On Wednesday, Thursday and Friday (Friday until noon), the Prop Information booth will be at the Memorial Union in Rom 2630.

# **Unloading at Competition Sites**

For props that travel with you, participants must load and unload their own props. Designated loading/unloading zone information will be available at team check in.

# **Prop Return Shipments**

Teams who wish to ship materials home must register such request with the ISU Prop Information booth for proper guidance. All teams are responsible to prearrange for PREPAID OR C.O.D shipment of any materials requiring return. All returns must be properly packaged and have a prepaid return shipping label AND an orange ISU "RETURN" label attached to each carton. A completed Bill of Lading (BOL) must be attached to the carton/crate(s) for all freight returns.

Props requiring return should be left in the prop storage rooms to allow for ISU

Props requiring return should be left in the prop storage rooms to allow for ISU Central Receiving to pick up and stage for carrier pick up at Central Receiving. Do not request a carrier pick up at the prop storage location. Schedule return shipments with your carrier after June 1.

Deadline to have return shipments registered with Prop Info Booth and properly packaged/labeled is NOON, Friday, May 24, 2024.



# **Check List**

## Before your team leaves home

- Have each team member fill out a medical release form and insurance information form and have it signed by a parent/guardian. Provide a copy to your coach, and keep one with you!
- Ship props between May 1 and May 17. Don't forget to attach the shipping label to each separate shipping item/package. Include only items for one problem and division in each package. Must abide to container sizes.
- Leave a list of all team members and chaperones' names and any cell phone numbers with family members.
- Pack clothes for recreational activities, such as a bathing suit, towel and tennis shoes.
- Leave the emergency number with family members. In the event of an emergency at home, family members should call ISU Police at 515.294.4428.
- Check on your props: go to isu.sclintra.com/OTM.
- Bring extra pillows if needed (you'll receive only one in residence housing) and universal plug-ins if coming from outside the US.


# Once you arrive

#### Consent for Services and Communication

#### Medical & Psychiatric Services • Email & Text

#### I, the undersigned, expressly consent to my (the patient's) medical treatment, including:

- 1. I authorize the healthcare professionals of Thielen Student Health Center (TSHC) and their designees and business associates, to administer medical tests, diagnostic procedures, and perform treatment, as considered medically or therapeutically necessary.
- 2. I understand that TSHC may share medical information with the health insurance company(ies) I have identified as providing me with coverage, as may be necessary to process claims for medical services rendered to me.
- 3. I authorize payment of health insurance benefits to TSHC for medical services rendered to me.
- 4. I understand my continued treatment at TSHC is contingent on enrollment at Iowa State University (ISU). Prior to graduation or leaving ISU, I agree to cooperate with my TSHC treatment team to transfer my care, if they request.
- 5. I understand that more detailed information about my rights as a patient, and the way my medical information may be used or released, is described in TSHC's Notice of Privacy Practices (NPP) and that TSHC's NPP has been made available to me.

#### For psychiatric treatment, where applicable, I agree and understand that:

- 1. Treatment may include prescription and monitoring of psychotropic medications, lab monitoring, referral, psychoeducation, sleep hygiene, brief psychotherapy, and other necessary treatments.
- 2. I acknowledge TSHC cannot guarantee me specific results of psychiatric tests, treatments, or any other services rendered.
- 3. I understand my psychiatrist and/or pharmacist will provide me with information about known side-effects of any medication administered or prescribed.
- 4. I am aware there are exceptions to confidentiality of psychiatric records, as described in the NPP. These include but are not limited to:
  - The TSHC staff work as a team. My psychiatrist and psychiatric nurse may consult with another TSHC psychiatrist or family practice provider to provide me with the best possible care.
  - If I pose a threat of harm to myself and/or others, TSHC will take whatever steps are required or permitted by law to help prevent the harm from happening.

#### For phone, email, and text messaging I agree and understand that:

legal equivalent of my handwritten signature and that I am legally bound by

- 1. TSHC will use the contact information I have provided the ISU Office of the Registrar, including phone, address and email address.
- TSHC may leave detailed appointment, medical care, test results, and billing information on voicemails at the phone number I provide to the ISU Office of the Registrar so long as the voicemail identifies me as the owner. Detailed messages will not be left on unidentified devices.
- 3. For my security and convenience, TSHC offers to communicate with me via encrypted email, including communications containing personally identifiable health information. Encryption best protects my health information. Encrypted email sent to my ISU sponsored email account will not look different from any other email. TSHC strongly recommends that email communications be sent from and received via my ISU sponsored email account only and not auto-forward to an unsecured or third- party system.
- 4. For my convenience, TSHC also offers me a choice of receiving text messages to remind me of upcoming appointments and/or care coordination activities. TSHC limits information sent via text message to the minimum necessary.
- 5. I also understand that:
  - TSHC considers all patient medical information as confidential. However, email users should never consider electronic communications to be entirely private or secure.
  - TSHC strongly recommends that email communications be sent from and received via my ISU sponsored email account.
  - I should NOT use email for any emergency situation or when an immediate or urgent response is needed.
  - I have the choice to "opt out" of receiving communications from TSHC via email and/or text.

#### Further, I agree and understand that:

- 1. I may be contacted for additional information regarding my health care or insurance coverage by TSHC.
- 2. I am responsible for, and agree to pay, all charges that exceed or are not covered by university student health fees and/or my health insurance coverage.
- 3. I understand that the unpaid medical charges will be transferred to the university billing system (U-Bill) and I may be contacted by ISU Accounts Receivable, if the charges remain unpaid.
- 4. I intend this consent to remain in effect, so long as I am a student at ISU. However, I understand I may withdraw this consent in writing.
- 5. My withdrawal will not be effective for actions already taken (or in the process of being taken) by TSHC.
- 5. If I am under age 18, my parent or legal representative must sign this form consenting to medical care on my behalf with the exception of the following types of healthcare that by Iowa law I am able to consent for myself:

I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the Climbing Wall, including, but not limited to:

- All manner of injury resulting from falling off the Climbing Wall and impacting against rock faces and projections, whether permanently or temporarily in place, or the Climbing Wall floor;
- Rope abrasion, entanglement and other injuries resulting from activities on or near the Climbing Wall such as, but not limited to climbing, belaying, rappelling, lowering on rope, rescue systems, and any other rope techniques;
- Injuries resulting from falling climbers or dropped items, such as but not limited to ropes or climbing hardware;
- Failure of climbing equipment such as ropes, slings, harnesses, climbing hardware, anchor points, or failure of any part of the Climbing Wall Structure.

I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the Climbing Wall and that the above list in no way limits the extent or reach of this release and covenant not to sue.
